All information received from you in connection with your application will be processed in accordance with the documented purposes as defined below. LCCM AU UK Limited ("we" or "us") is a part of the Global University Systems group of companies (the GUS Group). The information you provide on this application form will be processed in accordance with GUS Group's Privacy Notice which can be found on our website. Data Controller

For the purposes of your application, we are a data controller. We are a limited company registered in England and Wales with company number 11147959. Purpose of the Processing

(i) Processing your application:

We will use the details provided by you in this application to consider and process your application. We share your application and the personal data supplied in it with Global University Systems which carries out part of the application process for us. We enter into a contract with them which prohibits them from using your data for any purpose other than to perform the contract with us. The above processing of your personal data is justified under article 6 (1) (b) - necessary for the performance of a contract or in order to take steps at your request prior to entering into a contract.
